

Prudential Returns - Consumer Financing



While the attached revised Prudential Returns represents no major amendments to the Prudential Returns currently being submitted, banks should continue to submit their current Prudential Returns only for last quarter of 2014 in parallel with submission of the attached new Prudential Returns. Consequently, starting 1st quarter of 2015, only the new Prudential returns in the attached (Table 1) will need to be submitted to SAMA.

With regard to historical data, effective December 2014, Banks are expected to provide comparable data for each quarter from 1998 to 2014 as attached (Table 2) and submit to SAMA by end of January 2015.

These quarterly prudential returns are to be submitted as a soft copy to the attention of Dr. Alwaleed Alsheikh, Director of Banking Supervision and to the undermentioned parties. SAMA is also planning to induct this return on its Electronic Return Management System (ERMS) shortly and in this regard will accordingly inform the Banks as to the steps to be taken at their end.
